DISSERTATION

The dissertation deals with health and homelessness in 19 U.S. cities and is occasioned by the Health Care for the Homeless Project (HCH) which provides the largest data resource on homeless people in the United States. The research problem is continuity of care among homeless with peripheral vascular disease and related foot disorders (PVD). Continuity is measured as the time between visits for the PVD condition. Continuity is modeled as a function of predisposing individual, illness level, and health system characteristics. Data on client characteristics were derived from the larger HCH data base consisting of over 90,000 individuals. Data management involved linking client records over three years of program operation. Data on health system characteristics were derived from a telephone interview with Project Directors from the 19 Projects. Log-normal regression was used for the analysis of continuity. Findings reveal multiple sources of continuity. Specifically, continuity is affected by health system characteristics, net of predisposing individual and illness level predictors.
